RELEVANT EXTRACTS FROM THE AMENDED RAFOC CONSTITUTION

4. Interpretation

- g. "retired officer" means any commissioned officer who has retired or left the Malaysian Armed Forces on his own accord or on the end of his service, regardless if he is in receipt of a pension or not and has not been dishonourably discharged by a Court Martial or convicted by any court of law for a criminal offence;

6. Membership

- a. The categories of membership shall be as follows:
- (1) Ordinary Member
 - (2) Life Member
 - (3) Associate Member
 - (4) Honorary Member
- b. Any retired officer who was commissioned into any of the three Services of the Malaysian Armed Forces and has not been dishonourably discharged by a Court Martial or convicted by any court of law for a criminal offence shall be eligible to apply to be an Ordinary or Life Member of the Association.
- c. Any person who has been associated with the Malaysian Armed Forces by way of staff appointment, military or otherwise, and/or any family members of the retired officer who has since deceased, shall be eligible to apply as an Associate Member of the Association.
- d. Any person who has rendered distinguished service to the Association, the Malaysian Armed Forces and/or the nation may be conferred Honorary Membership of the Association.

7. Entrance Fees & Subscriptions

- a. The Entrance Fees for membership shall be as follows:

- b. The Annual Subscription for Ordinary and Associate Members shall be RM50.00 per annum and shall become due and payable annually on or before 31st December of each year. Life Members shall be exempted from paying the Annual Subscription.
